Request to issue letter of equivalency

This refers to your letter dated 07.12.2022 and the e-mail dated 20.02.2023 addressed to the Commissioner General of Examinations of Department of Examinations, Sri Lanka requesting a determination that the South Australian Certificate of Education is equivalent to the General Certificate of Education (Advanced Level) conducts by the Department of Examinations, Sri Lanka.

Please be informed that the General Certificate of Education (Advanced Level) Examination is the national level evaluation and confirmation exam conducts at the completion of upper senior secondary education of Sri Lanka. Even though, the main purpose of conducting this examination is to evaluate and certify performance level of each and every student, it is kindly mentioned that the results of this examination is officially accepted as the marking level to select suitable persons for national and international universities, other higher education and vocational training institutes and National Colleges of Education. Therefore, this examination is the landmark of evaluating one's educational performances and selecting as a suitable candidate for many other streams. The G.C.E.(A.L) is further considered as a measure point of qualifications for selecting to the tertiary level employments.

03. Having considered the facts and these important matters, the Department of Examinations, Sri Lanka has determined that the South Australian Certificate of Education (SACE) is equivalent to the General Certificate of Education (Advanced Level) of Sri Lanka.
